4. I understand and agree that I must wear appropriate personal protective equipment (PPE) at all times during horse riding activities, as required by The Hong Kong Jockey Club and in compliance with the standards of the British Horse Society (BHS). This includes, but is not limited to:

 - Suitable footwear with a defined heel (e.g., riding boots or shoes) to prevent slipping through stirrups.

 - A Jockey Skull Cap with no peak must be worn for cross country.
