

## Hong Kong Equestrian Performance Plan 2026

#### **SELECTION POLICY FOR ELITE AND POTENTIAL SQUADS**

#### **HKEPP Mission**

The aim of the Hong Kong Equestrian Performance Plan (HKEPP) is to achieve success for equestrian athletes from Hong Kong China competing on the world stage. This will be accomplished through a systematic approach to identify talent, develop potential and support successful athletes to achieve their goals.

## **Aims of the Selection Policy**

This policy is designed to select athletes on to the Performance Plan who demonstrate the potential ability to represent Hong Kong China in international competition, major equestrian Championships and Games, with the ultimate ambition of winning medals.

#### Introduction

The HKEPP was introduced by The Hong Kong Jockey Club (HKJC), in collaboration with The Equestrian Federation of Hong Kong, China in January 2016. This policy relates to the formal selection of athletes for the programme, running from 1 January 2026 to 31 December 2026. Selection on to the programme will take place annually and eligibility criteria are subject to change in future years.

The number of places on the programme and the structure of available support are dependent on funding levels made available by The Hong Kong Jockey Club and therefore subject to change.

# **HKEPP Programme Commitment**

Selection on to HKEPP takes place annually. Athletes who are accepted on to the programme will undertake formal performance reviews and will only remain on the programme if they continue to reach key performance targets as agreed with the Performance Manager. Failure to engage fully with the Performance Manager and work through a mutually agreed development plan may result in removal from the programme. Athletes will be required to sign an athlete agreement at the start of the programme, outlining their obligations to the HKJC and the Equestrian Federation of Hong Kong, China and their commitment to attend agreed competitions, squad sessions and home visits. The Athlete Awards and Target Payments for 2026 are detailed in Annex A.

## General eligibility for selection to the HKEPP - Elite Programme

To be eligible for consideration for the programme, all athletes must meet the following criteria:

 All athletes must be Hong Kong Special Administrative Region passport holders and eligible to compete for Hong Kong China in all FEI competitions, championships and major multi-sport Games.



- 2. All athletes must be current members of the Equestrian Federation of Hong Kong, China.
- 3. All athletes must maintain their sport nationality as Hong Kong China so as to represent Hong Kong China at all competitions.
- 4. Athletes currently serving a ban from FEI or national competition as a result of an equine or human doping or equine medication violation will not be eligible for selection.
- 5. Athletes must continue to have horse power available to them to continue to compete at the level of the relevant qualification results.
- 6. All Athletes must meet the Hong Kong Sports Institute minimum requirements of a top 2/3 position in at least one international FEI sanctioned competition in the previous 12 months.

# General eligibility for selection to the HKEPP - Potential Programme

To be eligible for consideration for the programme, all athletes must meet the following criteria:

1. All athletes must either be Hong Kong Special Administrative Region passport holders or have an application for naturalization as a Chinese National registered by the Immigration Department of the Hong Kong Special Administrative Region. Furthermore, athletes must meet the requirements laid down in Articles 7 and 8 of the Nationality Law of the People's Republic of China and satisfy the factors considered by the Immigration Department.

A receipt detailing the application reference from the Immigration Department of the Hong Kong Special Administrative Region will be required as proof of application.

Furthermore, athletes will be required to commit to renounce any foreign nationality to enable them to claim a Hong Kong Special Administration passport prior to their acceptance on to the Elite Squad or any long-list for a team representing Hong Kong China in competition that requires a HKSAR passport.

In the event that the application for naturalization as a Chinese National is rejected by the Immigration Department of the Hong Kong Special Administrative Region, the athlete becomes ineligible for the programme and will be removed immediately.

- 2. All athletes must be current members of the Equestrian Federation of Hong Kong, China.
- 3. All athletes must maintain their sport nationality as Hong Kong China so as to represent Hong Kong China at all competitions.



- 4. Athletes currently serving a ban from FEI or national competition as a result of an equine or human doping or equine medication violation will not be eligible for selection.
- 5. Athletes must continue to have horse power available to them to continue to compete at the level of the relevant qualification results.
- 6. All Athletes must meet the Hong Kong Sports Institute minimum requirements of a top 2/3 position in at least one international FEI sanctioned competition in the previous 12 months.
- 7. Athletes applying for the Potential Squad must not have previously been on the Elite Squad in any year.

# Specific Minimum Criteria for selection to the HKEPP

The HKEPP is divided into two distinct senior programmes:

# **HKEPP Elite Programme**

This programme is designed to support senior elite athletes who compete regularly in international competition in the discipline of dressage, eventing or show jumping. Within the programme there are three levels, determining the level of athlete funding. Each level has a qualifying criterion established for selection; please see the criteria at Annex B.

Athletes accepted on to the Elite Programme will remain at the designated level for the remainder of the year, even in the event of achieving results for the next level during the year. They may apply for the higher level at the next available application process for the following season (i.e., for 2027).

#### **HKEPP Potential Programme**

This programme is designed to support senior or under 25 elite athletes who compete regularly in international competition in the discipline of dressage, eventing or show jumping. It supports riders who are showing potential to progress on into the Elite programme. Athletes who have previously been on the Elite programme in any year are not eligible to apply for the Potential programme. The qualifying criteria for selection can be found at Annex B. The age of an athlete is at the time of the application.

#### General requirements on qualifying results

These general requirements are applicable to both elite and potential programme selection:

- All qualifying results must have been achieved between 16 November 2024 and 14 November 2025.
- Applicants who achieve criteria based on the National Games 2025 or the FEI Asian Championships 2025 in November and December will have these results considered and their selection outcome will be amended to reflect those results.



 Athletes who have not achieved the criteria results by 14 November 2025, will have an opportunity to apply for the programme at any point between 1 January 2026 to 25 September 2026. Athlete Award funding for such applications will be calculated pro-rata, subject to the month the application was received. An example table is shown below for an Elite Level One application received between January to September 2026:

All qualifying results must be verifiable on the FEI website results database. Athletes are responsible for liaising with the FEI with regards to any missing or incorrect results.

## **Young Horse Development Programme**

Elite or Potential Programme Athletes with young horses that achieve the following results will be eligible to apply for the Young Horse Development Programme, which allows access to Club funding towards competition expenses (entry fees and transport charges only).

An unlimited number of horses may be recognized for each Athlete, however, the number of entry fees claimable shall be capped as 12 per programme year (irrespective of the number of horses on programme). Events can include national shows affiliated to the respective NF or International Shows at the level shown in Annex C for each respective age group.

Transport reimbursements shall be capped at a maximum of EUR 1,000 (or equivalent) per show (not per horse), to a total of 6 shows per year. Shows that include multiple weeks (i.e. a"tour") shall be counted as one show for the purposes of reimbursing transport. Each week of a tour may count as separate shows for the purposes of reimbursing entry fees. Claims will only be paid on receipt of invoices to support the expenses.

To be eligible - results must be achieved as a combination with an athlete who is on the elite or potential programme. Horses do not need to be owned by the athlete. The qualifying criteria for selection can be found at Annex B.

#### **Application Process - Elite and Potential Squad:**

There are two opportunities to apply for places on the programme for 2026. The initial intake of athletes for January 2026 will be determined by round one of the application process. A second intake for athletes who have not achieved the criteria results for round one, will have an opportunity to apply for the programme at any point between 1 January 2026 to 25 September 2026; this is for athletes entering the programme at potential or elite level. For avoidance of doubt, athletes on potential can apply for the elite programme at any point between 1 January 2026 and 25 September 2026, however, athletes already on the elite programme are not able to move levels.

Details of the application process will be published on the Equestrian Federation of Hong Kong, China website. The application process will involve the completion of the HKEPP Application Form, which will be available as follows:

#### Round One opens: Monday 20 October 2025

The HKEPP Application Form must be fully completed and submitted by the deadline as follows:



**Round One closes**: 17:00 hours / 5:00pm Hong Kong time on Friday 14 November 2025 Late applications (after 14 November 2025 and before the 1 January 2026) will not be considered.

## Round Two applications will re-open 1 January to 25 September 2026.

# **Application Process - Young Horse Development Programme:**

Following a successful application to the Elite or Potential Squad, athletes wishing to apply for the Young Horse Development Programme are required to submit an email with proof of performance attached. The email should be addressed to <a href="mailto:robert.wl.wong@hkjc.org.hk">robert.wl.wong@hkjc.org.hk</a>. Results must be achieved as a combination with an athlete who is on the elite or potential programme. Horses do not need to be owned by the athlete. Athletes can apply from 1 January 2026 to 1 November 2026.

#### **Selection Process**

Athletes who meet the general eligibility criteria and the specific qualifying criteria for their discipline and level at the time of application will be awarded a place on the programme. For athletes who compete in more than one discipline, they will be awarded a place on the programme relative to their most successful discipline. If they are successfully accepted on to a second discipline on the programme, they will receive 50% of the level one funding on top of their primary discipline funding, irrespective of the level they trigger in the second discipline.

Applications will be reviewed by the Performance Manager to verify they meet the necessary criteria and final places on the programme will be recommended by the HKEPP Performance Director to the Equestrian Federation of Hong Kong China's Board, based on the Athlete's verified results. There will be no selection events / trials and the number of places on the programme is not limited.

The HKJC also reserve the right to award places on the programme outside the application process detailed above, if it can be deemed in the best interests of achieving the Aims of the Selection Policy.



# **Notification of Selection Decisions**

All applicants will be notified in writing (via email) of the selection decisions whether successful or not. Notifications will be sent as follows:

Round One application period: Monday 15 December 2025

**Round Two, applications after 1 January**: notification within 14 days of receipt of the application.

**Young Horse Development Programme**: notification within 14 days of receipt of the application.

# **Changes to Selection Policy**

The HKJC reserves the right to change the Selection Policy where necessary at any time if it is in the best interests of achieving the Aims of the Policy, only when the changes are approved by the Equestrian Federation of Hong Kong, China's Board and communicated via The Equestrian Federation of Hong Kong, China website.

# Confidentiality

At all times, confidentiality will be of the upmost importance to ensure the integrity of the selection process. All those involved, including but not limited to athletes, HKJC staff, Performance Management team and athlete support teams must uphold confidentiality on matters which may have a bearing on selection on to the programme. All confidential information, conversations and discussions will be identified as such. Any person who breaks this confidentiality will be removed from the process.

#### **RETENTION OF DOCUMENTS**

All documents relating to the selection process, including scores, results, meeting minutes, selection related emails, reasoning for decisions, appeal records etc. shall be retained by the HKJC for 8 years following completion of the selection (encompassing two major championship cycles).

# **Appeals Process**

Any appeal to the Selection decisions should be made in writing within 48 hours of the selection decision notification is received. Appeals should include full details for the reason for the appeal and should be addressed to the Executive Director of Racing, Mr. Andrew Harding at andrew.c.harding@hkjc.org.hk.

In the event that the Executive Director cannot satisfy the appellant, the applicant has the right to request to refer the appeal to the Equestrian Federation of Hong Kong, China President. The Equestrian Federation of Hong Kong, China President shall handle the appeal in accordance with the Terms of Reference for the Appeals Panel.
